**1. DATES OF PASSPORT TO PARADISE GETAWAY ENTRY.** Entries begin at 12:00:01 am Eastern Time ("ET") on November 1st, 2024, and end at 11:59:59 pm ET on November 30th, 2024 (the "Entry Period").

**2. ELIGIBILITY.** The Passport to Paradise Getaway is only open to legal residents of the contiguous United States and District of Columbia and Canada (excluding Quebec)

where permissible by law, who are of legal age of majority in the jurisdiction in which they reside (and at least 18 years old at the time of entry). Upon clicking the "Submit" button, the Entrant must complete the entry form in its entirety to include first name, last name, street address, city, state, zip, customer or Brand Partner ID if applicable, phone number, and email address, and click "Continue". Be sure you have clicked "Submit" on the Google form to receive one (1) entry into the Passport to Paradise Getaway.

(ii) **FREE ENTRY:** To enter without making a purchase, you must be a member of our Official Bravenly Breakthrough Community Group on Facebook and complete in its entirety the Google Entry Form online in the Official Bravenly Breakthrough Group.

Regardless of the entry method used to enter the Passport to Paradise Getaway, there is a limit of four entries per Entrant for the entire Sweepstakes Period. **4. DRAWING/ODDS.** By entering the Passport to Paradise Getaway Sweepstakes, Entrants fully and unconditionally agree to be bound by these Official Rules and the decisions of the Sponsor and Sweepstakes Entities, which will be final and binding in all matters relating to the Sweepstakes. ## 7. NOTIFICATIONS/CLAIMS.

Potential winners will be notified by Sponsor. Sponsor will notify winners via a post in the Official Bravenly Breakthrough Group. Winners must respond to the notification within two business days of the Notification. 11. DISPUTE RESOLUTION - BINDING ARBITRATION. Except as otherwise provided in these Rules, any controversy or claim arising out of or relating to the Sweepstakes, these Rules, or the breach thereof, shall be settled through arbitration. <u>The Parties waive all rights to trial by jury or to any court.</u> The arbitration shall be filed with, and administered by, the American Arbitration Association ("AAA") in accordance with the AAA's Consumer Arbitration Rules, which are available on the AAA's website at <u>www.adr.org</u>. Copies of the AAA's *Commercial Arbitration Rules* will also be emailed to you upon request to Sponsor. A dispute relating to whether the dispute between the Sponsor and you is subject to arbitration shall be decided through arbitration.

The Federal Arbitration Act shall govern all matters relating to arbitration. The law of the State of Florida, without regard to principles of conflicts of laws, shall govern all other matters relating to or arising from the Sweepstakes. The jurisdiction and venue of any matter not subject to arbitration shall reside in Pinellas County, State of Florida, or the United States District Court for the Middle District of Florida.

All arbitration proceedings shall be held in Seminole, Florida. There shall be one arbitrator selected from the panel that the AAA provides. Each party to the arbitration shall be responsible for its own costs and expenses of arbitration, including legal fees. Sponsor shall pay all administrative and filing fees. The decision of the arbitrator shall be final and binding on the parties and may, if necessary, be reduced to a judgment in any court to which the parties have consented to jurisdiction as set forth in these Rules. This agreement to arbitrate shall survive the cancellation or termination of the Sweepstakes. Either Party may, notwithstanding the provisions of this arbitration provision, bring qualifying claims in small claims court.

Notwithstanding the foregoing, nothing in these Rules shall prevent either party from applying to and obtaining from any court to which the parties have consented to jurisdiction as set forth herein a temporary restraining order, preliminary or permanent injunction, or other equitable relief to safeguard and protect its intellectual property rights, trade secrets, and/or confidential information.
